## Treasurer George Mudgett & the Spokane County Courthouse



This cover was sent in May, 1897 by Spokane County Treasurer George Mudgett to Walla Walla, Washington. Mudgett, 1857-1937, served as Treasurer from 1895-99 and 1901-05, was a former Spokane city councilman, and also served several terms in the Washington State Legislature.

The Spokane County Courthouse, shown at left, was constructed in 1894-95 and still exists. County officials moved into the new building in November, 1895, during George Mudgett's first term as County Treasurer. The Courthouse was designed by architect W.A. Ritchie and was inspired by two French Renaissance buildings, the Chateau de Chambord, built in 1519, and Chateau d'Azay Le Rideau, built in 1516.

Ritchie was then one of the most prominent architects in the state. Born in Ohio in 1864, he never attended a formal architecture school, and instead received his training from a correspondence course. After starting his career in the Mid West, Ritchie moved to Seattle in 1889. There he designed a number of public buildings, including the King County Courthouse in Seattle, the Jefferson County Courthouse in Port Townsend, and the Clarke County Courthouse in Vancouver. Ritchie also designed the old State Capitol building and the Thurston County Courthouse in Olympia as well as the Whatcom County Courthouse in Bellingham.
